**A Background**

An insert will be included with the 2009 tax year CCC-1099-G mailing explaining that additional resources were committed to ensuring that the 2009 CRP annual rental payments and 2009 DCP payments were timely and accurately processed, and that it is recommended the amounts shown on CC-1099-G be verified with the producers records.

CCC-1099-G mailing will begin approximately January 20, 2010.

As part of Farm Service Agency's (FSA) ongoing effort to improve our service, the 2009 Conservation Reserve Program (CRP) annual rental payments and 2009 Direct and Counter-Cyclical Program (DCP) final direct payments were transitioned into a new payment processing system. As a result, you may have experienced a delay in receiving your 2009 CRP and 2009 DCP payment - and for this we sincerely apologize.

Although we have devoted additional resources to ensuring that the payments you have received are correctly listed on the CCC-1099G, we recommend you verify the amounts shown on this form with your records. If you find that the amounts are not correct, or if you have questions regarding this form, please contact the administering FSA Service Center for the farm or farms for which the questionable program payments were received. If the FSA Service Center agrees that an amount(s) is incorrect or missing, you will be mailed a corrected Form CCC-1099-G. FSA/CCC will notify IRS of any changes to your reportable income.

Customer financial information including refund information, program payment amounts, and prior year 1099 information is now conveniently available via the internet through the FSA "Financial Inquiries" database (FSA-FI).
